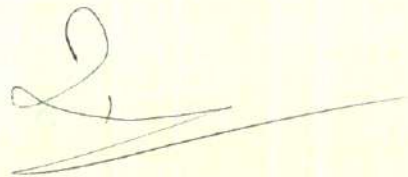
The Trust will be a public Charitable Trust and will be generally for the benefit of Public at large irrespective of caste, creed and religion.

1. OBJECTS:

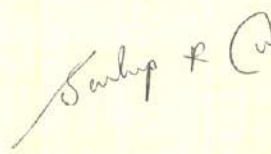
- (a) To spread the message of Brotherhood, Unity and Harmony.

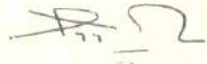

2. TRUST BOARD:

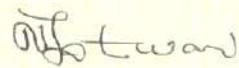

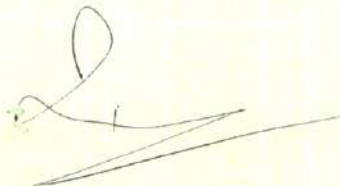


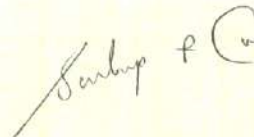
3. EXECUTIVE COMMITTEE:

- a) The Executive Committee of the Sadhu Vaswani Mission, Bangalore, will comprise of minimum 7 (seven) and minimum 15 (fifteen) Trustees. The Executive Committee members of Sadhu Vaswani Mission, Bangalore shall be appointed by the Managing Committee, Sadhu Vaswani Mission, Pune.
The Chair person, Sadhu Vaswani Mission, Pune (or her nominee) and three other Life Trustees of Sadhu Vaswani Mission, Pune will be the Trustees and members of the Executive Committee of Sadhu Vaswani Mission, Bangalore.
All the trustees referred to in Clause 2 have been appointed by the Sadhu Vaswani Mission, Pune as the first Executive Committee of the Trust.
- b) The Managing Committee of the Sadhu Vaswani Mission, Pune shall be competent to dissolve the EXECUTIVE COMMITTEE, and shall also be competent to suspend any member of the EXECUTIVE COMMITTEE OR TO REMOVE ANY member of the EXECUTIVE COMMITTEE without assigning any reason.
- c) The EXECUTIVE COMMITTEE will function for a period of three years, but the Managing Committee of the Sadhu Vaswani Mission, Pune may if they so desire extend the tenure of the EXECUTIVE COMMITTEE for a period of one year at a time.
- d) The Managing Committee of the Sadhu Vaswani Mission, Pune will have the power to appoint additional members of the EXECUTIVE COMMITTEE even during the tenure of its office.
- e) Vacancies created by resignation of members or otherwise will be filled by the Managing Committee of the Sadhu Vaswani Mission, Pune.

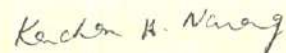

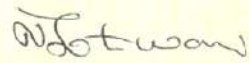


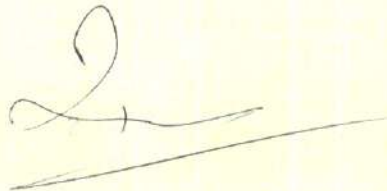
4. FUNCTIONS OF THE EXECUTIVE COMMITTEE.

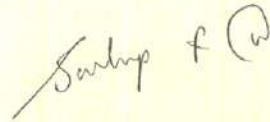
The functions of the EXECUTIVE COMMITTEE shall be as follows:

- i) To put into effect the Resolutions passed by the TRUST BOARD and any directive issued by the Managing Committee of the Sadhu Vaswani Mission, Pune.
- ii) To frame Rules and Regulations for obtaining and extending any sort of help or facilities for the Educational Institutions and Charitable Activities set up or undertaken by the TRUST.
- iii) To undertake any work within the frame work of the aims and objects of the trust.
- iv) To delegate any of its powers for any reason whatsoever to the Chairman / Vice Chairman and or Secretary / Joint Secretary and or Treasurer.
- v) To incur any expenditure in accordance with the budget and empower the Chairman to incur expenditure according to the needs in respect of items not covered by the budget.
- vi) To allow the use of the building or buildings or any portion thereof, under the control of the Trust, to any person or organization for a particular function (provided the function is not inconsistent with the objects of the Trust) and provided the same are not needed by the occupant institutions on those occasions.
- vii) To appoint establishment and staff such as Manager, Accountant, Clerk and etc., full time or part time as paid employees on reasonable salaries and allowances, are as Honorary employees giving them Honoraria or gifts, as and when consider desirable by the Board of Trustees.

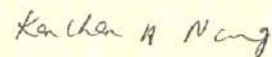

6. DUTIES AND POWERS OF THE OFFICE BEARERS:

A. CHAIRMAN:

- To make proper arrangement for paying the Salaries to the Staff engaged for the activities undertaken by the TRUST.
- To dispose of the correspondence carried on behalf of the Institution.
- To prepare the annual budget and the annual report on the working of the TRUST.

- i) To write off the Dead Stock items or dispose of old and unserviceable articles with the sanction of the Executive Committee.
- j) To allow the use of the building or buildings to an individual or an organization on payment of the requisite fee for one day or more when there is no likelihood of an early meeting of the Executive Committee.
- k) To carry on correspondence with any office and to attend any court cases on behalf of the Trust.
- l) To develop relations with other institutions having like objects.

D. TREASURER:

- i. To receive in cash or kind, the donations, contributions, gifts and other funds extended to the Trust.
- ii. To maintain up to date accounts of Income and Expenditure.
- iii. To prepare annual accounts for audit and get the accounts of the Trust audited by the Chartered Accountants and for placing the same before the annual meeting of the Trust.
- iv. To open account with suitable Schedule Banks and to generate the same jointly with the Chairman and / or the secretary as decided by the Board.

7. TRUST YEAR:

The Trust's year shall be Financial Year, i.e., Commencing on 1st April and ending on 31st March every year.

SPECIAL MEETING:

Special meeting for particular purposes may be called at the written request of one half of the members of the Trust Board for the time being.

NOTICE FOR MEETING :

- For ordinary and Annual Meetings 15 days notice shall be issued in advance.
- For emergent meetings, only one day notice will suffice.
- For special meetings, 7 days advance notice will be necessary.

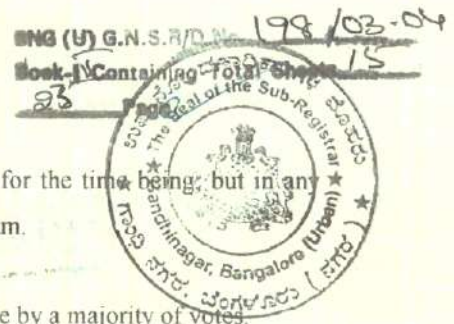

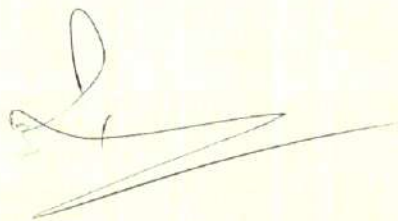

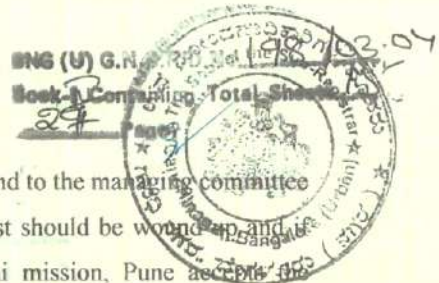

16. It is declared that the Trust and the benefits of the same are open to all irrespective of caste, creed and religion. The activities of the Trust shall be conformed to the Territory of India.

17. It is declared that the funds and income of the center (Trust) shall be solely utilized towards the objects of the Trust only and no portion of it shall be utilized for payment to Trustees or persons as defined in Section 13(1) (c) of the Income Tax Act 1961, by way of profit, Interest, Dividend etc.
